#### **AFFECTED STORES**

The County ordinance only affects stores located in the Unincorporated areas of Los Angeles County.

Single use plastic carryout bags will no longer be provided starting July 1, 2011 at supermarkets and large retail stores with a pharmacy in the unincorporated areas.

### Affected stores are defined as follows:

Large Stores - A full-line, self service retail store with gross annual sales of two million dollars, or more, that sells

a line of dry grocery, canned goods, or non-food items and some perishable items; or a store of at least 10,000 square feet of retail space that generates sales or use tax pursuant to the Bradley Burns Uniform Local sales and Use Tax Law and that has a pharmacy licensed pursuant to Chapter 9 of Division 2 of the Business and Professions Code.

On January 1, 2012, smaller grocery, convenience, and liquor stores; meat markets; and pharmacies will comply with the ordinance.

**Small**—A pharmacy or a grocery store, convenience store, food mart, or other store engaged in the retail sale of a limited line of goods that includes milk, bread, soda, and snack foods, including those stores with a Type 20 or 21 license issued by the Department of Alcoholic Beverage Control.

For stores located in the Incorporated Cities, contact the city clerk's office to find out if they have adopted a similar ordinance.

## July 1, 2011 - Large Stores January 1, 2012 - Small Stores

The Los Angeles County Board of Supervisors has adopted an Ordinance banning single use plastic carryout bags at stores in the County Unincorporated Areas, while requiring those stores affected to charge 10 cents (\$0.10) for each paper bag provided to a customer.

The ordinance goes into effect on **July 1, 2011,** for "Large" stores; and on **January 1, 2012,** "Small" stores will be affected.

#### **ENFORCEMENT**

If you believe that a store is unlawfully handing out plastic bags (excluding produce bags) or not charging for paper bags, please contact the County of Los Angeles Department of Public Works at 1 (888) CLEAN LA or report the incident by visiting: www.AboutTheBag.com.
