### **PUBLIC EDUCATION AND INFORMATION SUBCOMMITTEE**

On behalf of the Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force), I extend an invitation to your City to participate in the Task Force's Public Education and Information Subcommittee.

Pursuant to Chapter 3.67 of the Los Angeles County Code and the California Integrated Waste Management Act of 1989 (AB 939, as amended), the Task Force is responsible for coordinating the development of all major solid waste planning documents prepared by the County and the 88 cities in the County of Los Angeles. Consistent with these responsibilities and to ensure a coordinated and cost-effective solid waste management system, the Task Force addresses issues impacting the solid waste management system on a Countywide basis. The Task Force membership includes representatives of the League of California Cities-Los Angeles County Division, Los Angeles County Board of Supervisors, City of Los Angeles, the waste management industry, environmental groups, the public, and a number of other governmental agencies.

The Public Education and Information Subcommittee's goal is to enhance communication and collaboration between the Task Force, the County, and Cities regarding solid waste management issues. Accordingly, the Subcommittee publishes the *Inside Solid Waste* quarterly newsletter which includes articles about current news and events, proposed legislative bills and regulatory proposals impacting local jurisdictions, waste prevention and recycling tips, and successful waste diversion programs (the newsletter is available online at [www.lacountyiswmf.org](http://www.lacountyiswmf.org)). Currently, the Subcommittee consists of industry, the County, and a number of cities and other stakeholders. To ensure a broad representation of cities, the Subcommittee is currently recruiting new members. We would be pleased if your City joins the Subcommittee. The Subcommittee meets on a quarterly basis with the next meeting scheduled for February 16, 2006, at the County of Los Angeles Public Works Headquarters, 900 South Fremont Avenue, in Alhambra.
