ASSEMBLY BILL 45 – OPPOSE SOLID WASTE: HOUSEHOLD HAZARDOUS WASTE

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) strongly urges your City to oppose and, subject to your availability, testify against Assembly Bill 45 (AB 45), as amended on January 21, 2016, for a multitude of unworkable issues expressed in this letter. For your consideration and use, a draft letter of opposition addressed to the Chair of the Senate Environmental Quality Committee, Bob Wieckowski, is enclosed.

If enacted, AB 45, as proposed, would negate the legislative precedent and legal authority of local jurisdictions to enact their own local pharmaceutical or sharps ordinances that would require manufacturers of prescription drugs, sharps, batteries, and other "household hazardous waste", to partake in the shared responsibility for the collection and proper management of this material. Instead, this bill is intended to only require manufactures to provide an insultingly low amount of funding for local jurisdictions' outreach activities. The current language of the bill specifies manufactures to provide \$5 million in grants to local jurisdictions over 5 years, which according to the California Product Stewardship Council (CPSC), each county would only receive an average of \$17,241 (just over \$2,000 per city), an insignificant amount of the funding needed to fully and effectively address the problem. The \$5 million over 5 years is an insult to local government and is not consistent with the findings and declarations of the bill stating that this is an "extraordinary challenge."

As demonstrated in other jurisdictions in the State, including Alameda County, San Francisco County, Santa Barbara, and Marin County, local ordinances provide residents with convenient means of safe disposal of unwanted sharps and pharmaceuticals while preventing these products from entering the environment where they become vulnerable to drug abuse and misuse and inflict injuries associated with sharps being improperly disposed. These local ordinances are the definition of Extended Producer Responsibility (EPR), and thus, AB 45 is counterintuitive to CalRecycle's adopted EPR framework, which outlines the appropriate role for producers and others in the system to go well beyond public education. Additionally, the bill discounts the findings highlighted in the AB 341 Report to the Legislature that recommends an EPR strategy for managing Household Hazardous Waste (HHW).

At present the bill sits in the Senate Environmental Quality Committee awaiting further debate and action at its scheduled hearing this coming Wednesday, June 29, 2016. Consistent with the enclosed letter of opposition from the League of California Cities – Los Angeles County Division, dated April 15, 2016, we strongly urge each city to forward a letter of opposition addressed to the Senate Environmental Committee and/or send representation of your respective organization to attend the Committee's critical hearing scheduled for June 29, 2016, to provide testimony on the detrimental effects this inequitable bill would have on your communities and the resources you need to protect them with.

Pursuant to the California Integrated Waste Management Act of 1989 (Assembly Bill 939 as amended) and Chapter 3.67 of the Los Angeles County Code, the Task Force is responsible for coordinating the development of all major solid waste planning documents prepared for the County of Los Angeles and the 88 cities in Los Angeles County with a combined population in excess of ten million. Consistent with these responsibilities and to ensure a coordinated and cost-effective and environmentally sound solid waste management system in Los Angeles County, the Task Force also addresses issues impacting the system on a countywide basis. The Task Force membership includes representatives of the League of California Cities-Los Angeles County Division, County of Los Angeles Board of Supervisors, City of Los Angeles, the waste management industry, environmental groups, the public, and a number of other governmental agencies.

Notice of Opposition.

Dear Assembly Member Mullin:

On behalf of the Los Angeles County Division (Division) of the League of California Cities®, representing 86 cities in the County, I write to inform you of our opposition to your AB 45 which requires CalRecycle, in consultation with affected industries and stakeholders to adopt one or more model ordinances for a comprehensive program for the collection of Household Hazardous Waste (HHW) for adoption by any local jurisdiction that provides residential solid waste collection and disposal services.

Regrettably, AB 45 overlooks the recommendations in CalRecycles' AB 341 Report to the Legislature, which recommends an Extended Producer Responsibility strategy for managing HHW. Extended producers, such as pharmaceutical companies, need to manage and fund pharmaceutical and sharps collection entirely and throughout the state. AB 45 has neglected to recognize that, pursuant to existing State Law (the California Integrated Waste Management Act), each local government has already prepared and adopted a HHW Element, which has been approved by CalRecycle.

In an effort to be proactive, Los Angeles County has proposed the Los Angeles County Pharmaceuticals and Sharps Collection and Disposal Stewardship ordinance. The Division strongly supports this proposed ordinance and we expect robust participation among cities if a final version is adopted by the Los Angels County Board of Supervisors. Ultimately, costs should not solely come from local jurisdictions and ratepayers. AB 45 is deficient in establishing producer responsibility for products contributed to the waste stream.
