OPPOSE ASSEMBLY BILL 890 (MEDINA): LOCAL LAND USE INITIATIVES: ENVIRONMENTAL REVIEW

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) strongly **opposes** Assembly Bill 890 (AB 890), as amended May 10, 2017. If enacted, AB 890, among other things, would (a) require local governments to determine whether a proposed local initiative measure constitutes a project under California Environmental Quality Act (CEQA) within 15 days after the measure is filed; (b) require a local agency to prepare a summary of that analysis; and (c) within five days of completion of analysis, submit the summary of the analysis to the initiative proponents. The bill would also establish that the provision of the summary of the analysis to the initiative proponents within 5 days of completing the CEQA analysis, would constitute approval of the initiative by the local jurisdiction for the purposes of CEQA. Further, the bill would require the jurisdiction to submit the proposed initiative, without alteration, to the voters at a special election. AB 890 raises serious concerns for local governments on many fronts.

Under this bill, local governments would be required to conduct an environmental review resulting in a tremendous cost and work load increase to the jurisdiction. In addition, the jurisdiction would have no discretion to actually comply with CEQA as the bill requires the lead agency to provide a summary of the analysis to the proponent and by providing this information, would deem the project approved. AB 890 would compel jurisdictions to call a special election for all proposed ballot measures for which an environmental review is conducted. This process can be considerably expensive for a local jurisdiction to conduct a standalone special election. Finally, this bill exposes local governments to significant liability and unacceptable risk that the jurisdiction has no control to mitigate. Even though the measure would be decided by the voters, the jurisdiction is liable for faults relating to CEQA and takes all discretion away from the lead agency in terms of project approval.

Pursuant to the California Integrated Waste Management Act of 1989 (Assembly Bill 939) and Chapter 3.67 of the Los Angeles County Code, the Task Force is responsible for coordinating the development of all major solid waste planning documents prepared for the County of Los Angeles and the 88 cities in Los Angeles County with a combined population in excess of ten million. Consistent with these responsibilities and to ensure a coordinated and cost-effective and environmentally sound solid waste management system in Los Angeles County, the Task Force also addresses issues impacting the system on a countywide basis. The Task Force membership includes representatives of the League of California Cities-Los Angeles County Division, County of Los Angeles Board of Supervisors, City of Los Angeles, the waste management industry, environmental groups, the public, and a number of other governmental agencies.
