SUPPORT IF AMENDED - OPPOSE UNLESS AMENDED - SENATE BILL 168 (WIECKOWSKI) AS AMENDED ON JULY 5, 2018 - RECYCLING: BEVERAGE CONTAINERS

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) **supports** Senate Bill 168 (SB 168), as amended on July 5, 2018, provided it is **amended** as indicated in this letter, and **opposes** it **unless amended** as indicated in this letter.

If enacted, SB 168 would require CalRecycle, on or before January 1, 2021, to establish minimum content standards for beverage containers that are constructed of metal, glass, or plastic, or other material or combination thereof, including recycled materials. The bill would require CalRecycle on or before January 1, 2020, to evaluate other beverage container redemption programs and to provide to the Legislature a report on aspects of those programs that may be incorporated into California's beverage container redemption program. SB 168 would also authorize CalRecycle to adjust the minimum content standards but not more frequently than annually.

The Task Force is in favor of establishing minimum content standards for beverage containers as this supports the expansion of recycling markets and infrastructure in California while simultaneously reducing waste, energy consumption and air pollution. Furthermore, SB 168 can reduce California's reliance on exporting recyclable materials and address some of the challenges posed by China's National Sword policy.

However, the Task Force has concerns with the methodology to task CalRecycle with establishing minimum content standards without input from industry groups and local jurisdictions as this may result in inefficient standards and undermine the intent of the bill. Therefore, the Task Force recommends amending the bill to include a working group comprised of beverage and recycling industry groups, local jurisdictions, and other stakeholders to work with CalRecycle on establishing minimum content standards for beverage containers.

Pursuant to Chapter 3.67 of the Los Angeles County Code and the California Integrated Waste Management Act of 1989 (AB 939), the Task Force is responsible for coordinating the

development of all major solid waste planning documents prepared for the County of Los Angeles and the 88 cities in Los Angeles County with a combined population in excess of ten million. Consistent with these responsibilities and to ensure a coordinated and cost-effective and environmentally sound solid waste management Los Angeles County, the Task Force also addresses issues impacting the system on a countywide basis. The Task Force membership includes representatives of the League of California Cities-Los Angeles County Division, County of Los Angeles Board of Supervisors, City of Los Angeles, waste management industry, environmental groups, the public, and a number of other governmental agencies.

Based on the foregoing, the Task Force **supports** SB 168 **if amended** to include a working group comprised of beverage and recycling industry groups, local jurisdictions, and other stakeholders, and **opposes** SB 168 **unless amended** to include a working group comprised of beverage and recycling industry groups, local jurisdictions, and other stakeholders.
