Business Incentive and Support Program


•General Plan Amendment to ensure consistency with revisions

Main Elements

Green Zones Districts – additional requirements within 500 feet of a sensitive use.

New Sensitive Uses – new development standards for new sensitive uses near existing recycling and solid waste facilities.

Recycling and Waste Management Revisions – allow permitting of organic waste facilities and additional requirements for future recycling and solid waste facilities.

Storage Enclosures for Recycling and Solid Waste Revisions – additional requirements for construction, maintenance, distance, circulation, etc.

Addition of New Uses and Re-defining/Categorizing Uses – addition of specific recycling and solid waste uses, such as anaerobic digestion, chipping and grinding, mulching, and composting.

Effects

•Supports Bottle Bill, Assembly Bill 341, and Senate Bill 1383 compliance

•Facilitates recycling and organic waste processing through clear zoning requirements and simplified permitting

•Creates new requirements on facility development in:

Hillside Management Areas (HMAs)	Los Angeles County Floodways
Significant Ecological Areas (SEAs)	FEMA 100-Year Flood Zones
Very High Fire Hazard Severity Zones (VHFHSZs)	Within 1,500 feet of a lot containing sensitive uses
Agricultural Resources Areas (ARAs)	

Timeline

•Public review draft ordinance - May 22, 2020

Initial Study - June 2020

•A Notice of Preparation and Notice of Scoping for an Environmental Impact Report (EIR) - June 2020


•Public Meetings – July – August 2020

•Regional Planning Commission hearing - expected early 2021
