Dear Senators Florez and Runner:

SENATE BILL 1835 (AMENDED APRIL 18, 2006) CLARIFYIING PERMIT REQUIREMENTS FOR SOLID WASTE FACILITIES APPROVED VIA LOCAL BALLOT INITIATIVE

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) **supports** Senate Bill 1835 (SB 1835), which would prohibit solid waste facility project proponents from circumventing, among other things the land use permit process.

Pursuant to Chapter 3.67 of the Los Angeles County Code and the California Integrated Waste Management Act of 1989 (Assembly Bill 939, as amended), the Task Force is responsible for coordinating the development of all major solid waste planning documents prepared for the County of Los Angeles and its 88 cities in Los Angeles County. Consistent with these responsibilities and to ensure a coordinated and cost-effective solid waste management system in Los Angeles County, the Task Force also addresses issues impacting the system on a Countywide basis. The Task Force membership includes representatives of the League of California Cities-Los Angeles County Division, County of Los Angeles Board of Supervisors, City of Los Angeles, waste management industry, environmental groups, the public, and a number of other governmental agencies.

Currently, local, State and Federal governments take an active role in ensuring that solid waste facilities so that they do not pose a risk to public health and safety or the environment. For example, prior to granting a land use permit for a landfill, the host jurisdiction conducts an extensive environmental review of the proposal, including preparation and certification of the California Environmental Quality Act (CEQA) document, identifying mitigating measures to reduce negative impacts, and through permit conditions, setting specific criteria for design and operation of the facility. Such permit conditions are

often significantly more restrictive than the mitigation measures identified in the CEQA document.

However, these safeguards would be jeopardized by projects approved directly through a local ballot initiative, because the ballot initiative has the authority to supersede the host jurisdiction's land use authority. SB 1835, if enacted, would close this loophole by requiring those projects approved at the ballot to receive all necessary permits, including compliance with the host jurisdiction's land use and/or zoning requirements, prior to issuance of the Solid Waste Facility Permit by the Local Enforcement Agency and concurrence by the California Integrated Waste Management Board.
