Mr. Mark McDannel, Supervising Engineer for the Los Angeles County Sanitation Districts (CSD), provided a [PowerPoint presentation](#) of CSD's Food Waste Program at the Joint Water Pollution Control Plant in Carson. CSD has entered into a two-year demonstration program agreement with Waste Management, Inc. (Waste Management) to deliver up to 84 tons per day of pre-processed food waste slurry collected primarily from restaurants, food processing plants, and grocery stores.
